Food & Drink Vendors are open 11 am- 4 pm. Concert goers arrive as early as 9:30 am, you are welcome to set up and start serving as early as 10 am.

I understand and agree to the following:

1. All vendors must be self-contained (provide your own generator if electricity is needed. **Initial**)
2. The City and Palm Springs Opera Guild do not provide water, ice, supplies, tables, canopy, chairs or electricity. **Initial**
3. You will be assigned a specific location at event location (Sunrise Park, Palm Springs). You agree to the location identified on the approved map for the event and will not move unless authorized by event staff. **Initial**
4. Vendors set up is **8-10 am, Sunday, April 7, 2019**. Health Department inspection may start at 10 am. All food trucks must be parked in assigned areas and display all permits. **Initial**
5. Exiting - Vendors must clean up their space completely, taking all unused product, boxes, supplies, etc. No trash or debris of any kind may be left. You agree to a \$75 credit card charge if your space is not left in the same condition as arrival **Initial**
6. VENDORS MUST OBTAIN A CITY OF PALM SPRINGS SPECIAL EVENT PERMIT. **Initial**
7. Vendors shall provide a \$1,000,000 general liability insurance policy covering the City of Palm Springs, the Palm Springs Opera Guild and Opera in the Park Concert. Your certificate of insurance must accompany this agreement. A copy of my valid insurance is attached. **Initial**
8. INSURANCE WAIVER: Vendors agree to hold harmless the City of Palm Springs, Palm Springs Opera Guild and the Opera in the Park committee, its officers, staff, and volunteers should an incident occur. **Initial**
9. Vendors will have Health Permits and follow all health codes. **Initial**

REQUIREMENTS: 1) Food Vendors will need a Health Department permit. Contact the Riverside County Environmental Health Department at (760) 863-8287. 2) Vendors will need a special event one-day permit from the City of Palm Springs (available at Palm Springs City Hall, Business License Department (760) 323-8289). Vendor arriving after 10 am, may be refused entry by vehicle due to safety and forfeit their space and fees. 3) Propane users require a fire department permit. All use of propane in conjunction with cooking, heating, must be pre-approved by the Palm Springs Fire Department. Permit must be displayed. No BBQ's.
